All Dronfield schools have a similar approach to meeting the needs of pupils with Special Educational Needs and are supported by the Local Authority to ensure that all pupils, regardless of their specific needs, make the best possible progress in school. All schools are supported to be as inclusive as possible, with the needs of pupils with a Special Educational Need(s) and or disabilities being met in a mainstream setting wherever possible, where families want this to happen.

And how can I talk to them about my child if I need to?</p>	<p><b>Class Teacher</b></p>	<p><b>He/ She is responsible for:</b></p> <ul style="list-style-type: none"> <li>• Ensuring that all children have access to good/outstanding teaching and that the curriculum is adapted to meet your child's individual needs (also known as differentiation).</li> <li>• Checking on the progress of your child and identifying, planning and delivering any additional help your child may need (this could be things like targeted work, additional support, adapting resources etc..) and discussing amendments with the Inclusion Manager as necessary.</li> <li>• Ensuring that all members of staff working with your child in school are aware of your child's individual needs and/or conditions and what specific adjustments need to be made to enable them to be included and make progress.</li> <li>• Ensuring that all staff working with your child in school are supported in delivering the planned work/programme for your child, so they can achieve the best possible progress. This may involve the use of additional adults, outside specialist help and specially planned work and resources.</li> <li>• Ensuring that the school's SEND Policy is followed in their classroom and for all the pupils they teach with any SEND.</li> </ul>

	<p><b>The SENDCO (special educational needs and disabilities coordinator) is Mr Matthew Winson</b></p>	<p><b>He/ She is responsible for:</b></p> <ul style="list-style-type: none"> <li>• Coordinating all the support for children with special educational needs (SEN) and or disabilities, and developing the school’s SEND Policy to make sure all children get a consistent, high quality response to meeting their needs in school.</li> <li>• Ensuring that you are: <ul style="list-style-type: none"> <li>• involved in supporting your child’s learning</li> <li>• kept informed about the support your child is getting</li> <li>• involved in reviewing how they are doing</li> <li>• part of planning ahead for them.</li> </ul> </li> <li>• Liaising with all the other people who may be coming into school to help support your child’s learning e.g. The Speech and Language Therapy Service, The Educational Psychologist.</li> <li>• Updating the school’s SEND record of need, (a system for ensuring all the special educational, physical and sensory needs of pupils in this school are known and understood) and making sure that there are excellent records of your child’s progress and needs.</li> <li>• To provide specialist support for teachers and support staff in the school so they can help your child (and other pupils with SEN and/or disabilities in the school) to achieve their potential.</li> <li>• Supporting your child’s class teacher to write Individual Education Plans (IEPs)</li> <li>• Organising training for staff so they are aware and confident about how to meet the needs of your child and others within our school.</li> </ul>
	<p><b>Teaching Assistant (TA)</b></p>	<p>A teaching assistant (TA) may be allocated to a pupil with exceptional special educational needs and/or disabilities and whilst they take a very valuable role in your child’s education we would prefer that questions regarding your child’s learning and progress are directed in the first instance to the staff members named above.</p>
	<p><b>Headteacher, Mr Matthew Winson</b></p>	<p><b>He is responsible for:</b></p> <ul style="list-style-type: none"> <li>• The day to day management of all aspects of the school, this includes the support for children with SEN and/or disabilities. He will give responsibility to the SENDCO and class teachers but is still responsible for ensuring that your child’s needs are met.</li> </ul>

	<p><b>SEND Governor Mrs M Clark</b></p>	<ul style="list-style-type: none"> <li>• He must make sure that the Governing Body is kept up to date about any issues in the school relating to SEND.</li> </ul> <p><b>He/ She is responsible for:</b></p> <ul style="list-style-type: none"> <li>• Making sure that the school has an up to date SEND Policy.</li> <li>• Making sure that the school has appropriate provision and has made necessary adaptations to meet the needs of all children in the school.</li> <li>• Making sure that the necessary support is made for any child who attends the school who has SEN and/or disabilities.</li> <li>• Making visits to understand and monitor the support given to children with SEND in the school and being part of the process to ensure your child achieves his/her potential in school.</li> </ul>

**B. HOW COULD MY CHILD GET HELP IN SCHOOL?**

Children in school will get support that is specific to their individual needs. This may be all provided by the class teacher or may involve:

- Other staff in the school
- Staff who will visit the school from the Local Authority central services such as the ASD Outreach Team or Sensory Service (for students with a hearing or visual need)
- Staff who visit from outside agencies such as the Speech and Language Therapy (SALT) Service.

This may involve things like using more practical learning or providing different resources adapted for your</li> </ul>	<p>All children in school receive this.</p>

This will help the school and yourself understand your child's particular needs better.</li> <li>• The specialist professional will work with your child to understand their needs and make recommendations, which may include:</li> <li>• Making changes to the way your child is supported in class e.g. some individual support or changing some aspects of teaching to support them better</li> <li>• Support to set targets which will include their specific professional expertise</li> <li>• Your child's involvement in a group run by school staff under the guidance of the outside professional e.g a social skills group or sensory circuit</li> <li>• A group or individual work with outside professional</li> <li>• The school may suggest that your child needs some agreed individual support or group support in school. They will tell you how the support will be used and what strategies will be put in place.</li> </ul>	
	<p><b>Specified Individual support</b></p> <p><i>This is usually provided via a Statement of Special Educational Needs or an Education, Health and Care Plan (EHCP).</i> This means your child will have been identified by the class teacher/SENDCO as needing a <b>particularly high level of individual and small group teaching</b> which</p>	<ul style="list-style-type: none"> <li>• The school (or you) can request that the Local Authority carry out a statutory assessment of your child's needs. This is a legal process and you can find more details about this in the Local Authority (LA) based Local Offer, on the Derbyshire County Council web site: <a href="http://www.derbyshire.gov.uk">www.derbyshire.gov.uk</a></li> <li>• After the school have sent in the request to the Local Authority (with a lot of information about your child, including some from you), they will decide whether they think your child's needs (as</li> </ul>	<p>Children whose learning needs are:</p> <ul style="list-style-type: none"> <li>• Severe, complex and lifelong</li> </ul>

	<p>cannot be provided from the resources already delegated to the school.</p> <p>Usually, if your child requires this high level of support they may also need specialist support in school from a professional outside the school. This may be from:</p> <ul style="list-style-type: none"> <li>• Local Authority central services such as the ASD Outreach Team or Sensory Service ( for students with a hearing or visual need)</li> <li>• Outside agencies such as the Speech and Language therapy (SALT) Service, Occupational therapy service, Physiotherapy, service to support physical impairment and/or CAMHS</li> </ul>	<p>described in the paperwork provided), seem complex enough to need a statutory assessment. If this is the case they will ask you and all professionals involved with your child to write a report outlining your child’s needs. If they do not think your child needs this, they will ask the school to continue with the support at School Action Plus.</p> <ul style="list-style-type: none"> <li>• After the reports have all been sent in the Local Authority will decide if your child’s needs are severe, complex and lifelong and that they need additional support in school to make good progress. If this is the case they will write a Statement of Special Educational Needs or an EHC Plan. If this is not the case, they will ask the school to continue with the existing SEN support and also set up a meeting in school to ensure a plan is in place to ensure your child makes as much progress as possible.</li> <li>• The Statement or EHC Plan will outline the number of hours of individual/small group support your child will receive from the LA and how the support should be used and what strategies must be put in place. It will also have long and short term goals for your child.</li> <li>• Additional adults may be used to support your child with whole class learning, run individual programmes or run small groups including your child.</li> </ul>	
<p><b>How will we support your child with identified special needs when starting school?</b></p>	<ul style="list-style-type: none"> <li>• We will first invite you to visit the school with your child to have a look around and speak to staff.</li> <li>• If other professionals are involved, a Team Around the Child (TAC) or similar meeting may be held to discuss your child’s needs, share strategies used, and ensure provision is put in place before your child starts.</li> <li>• We may suggest adaptations to the settling in period to help your child to settle more easily.</li> <li>• If applicable visits to previous settings may be carried out to facilitate a successful transition.</li> </ul>		

<p><b>How can I let the school know I am concerned about my child's progress in school?</b></p>	<ul style="list-style-type: none"> <li>• If you have concerns about your child's progress you should speak to your child's class teacher.</li> <li>• If you are not happy that the concerns are being managed and that your child is still not making progress you should speak to the SENDCO or Headteacher.</li> <li>• If you still have concerns you can speak to the school SEN Governor.</li> </ul>
<p><b>How will the school let me know if they have any concerns about my child's learning in school?</b></p>	<ul style="list-style-type: none"> <li>• When a teacher or a parent has raised concerns about your child's progress, and targeted teaching has not met the child's needs, the teacher will raise this with the SENDCO.</li> <li>• Schools also have regular meetings every term to ensure all children are making good progress. This is another way your child may be identified as not making as much progress as expected.</li> <li>• If your child is then identified as not making progress the school will make a decision about whether to monitor this or set up an intervention group and will inform you.</li> <li>• If your child is still not making expected progress the school will discuss with you: <ul style="list-style-type: none"> <li>○ any concerns you may have</li> <li>○ any further interventions or referrals to outside professionals to support your child's learning</li> <li>○ how school and home can work together, to support your child..</li> </ul> </li> </ul>
<p><b>How is extra support allocated to children and how do they move between the different levels?</b></p>	<ul style="list-style-type: none"> <li>• The school budget, received from DCC, includes money for supporting children with SEN.</li> <li>• The Headteacher decides on the budget for Special Educational Needs in consultation with the school governors, on the basis of the needs of the children currently in the school.</li> <li>• The Headteacher and the SENDCO discuss all the information they have about SEN in the school, including: <ul style="list-style-type: none"> <li>○ the children getting extra support already</li> <li>○ the children needing extra support</li> <li>○ the children who have been identified as not making as much progress as would be expected.</li> </ul> They then decide what resources/training and support is needed. </li> <li>• All resources/training and support are reviewed regularly and changes made as needed.</li> </ul>

**Who are the other people providing services to children with SEN in this school?**

<p><b>How are the adults in school helped to work with children with a SEND and what training do they have?</b></p>	<ul style="list-style-type: none"> <li>• The SENCO's job is to support the class teacher in planning for children with SEN.</li> <li>• The school has a school development plan, including identified training needs for all staff to improve the teaching and learning of children including those with SEND. This may include whole school training on SEND issues or to support identified groups of learners in school, such as ASD and dyslexia.</li> <li>• Whole staff training to disseminate knowledge, strategies and experience, to ensure consistency of the school's approach for children with a SEND.</li> <li>• Individual teachers and support staff attend training courses run by outside agencies that are relevant to the needs of specific children in their class</li> </ul> <p><b>Training in the 2015/16 academic year has consisted of:</b> building on staff's awareness of sensory barriers to learning, support with writing IEPs, recapping on procedures for identifying need, a recap on precision teaching, using targets to support children effectively, engaging and support less able readers with a particular emphasis on boys.</p>
<p><b>How will the teaching be adapted for my child with learning needs (SEN/ and or disabilities)</b></p>	<ul style="list-style-type: none"> <li>• Class Teachers plan lessons according to the specific needs of all groups of children in their class, and will ensure that learning tasks are adjusted in order to enable your child to access their learning as independently as possible.</li> <li>• Specially trained support staff can implement the teachers modified/adapted planning to support the needs of your child where necessary.</li> <li>• Specific resources and strategies will be used to support your child individually and in groups.</li> <li>• Planning and teaching will be adapted on a daily basis if needed to meet your child's learning needs and increase your child's access to what is on offer.</li> </ul>
<p><b>How will we measure the progress of your child in school? And how will I know about this?</b></p>	<ul style="list-style-type: none"> <li>• Your child's progress is continually monitored by his/her class teacher.</li> <li>• His/her progress is reviewed formally every term in Reading, Writing and Maths as well as progress in other areas, as appropriate, such as attendance, engagement in learning and behaviour.</li> <li>• If your child is in Year 1 and above, but is not yet at National Curriculum levels, a more sensitive assessment tool is used which shows their level in more detail and will also show smaller but significant steps of progress. The levels are called 'P levels'.</li> <li>• At the end of each key stage (i.e. at the end of year 2 and year 6) all children are required to be formally assessed using Standard Assessment Tests (SATs). This is something the government requires all schools to do and are the results that are published nationally.</li> <li>• The progress of children with a statement of SEN/ EHC Plan is formally reviewed at an Annual</li> </ul>

Review with all adults involved with the child's education.

- The SENDCO will also check that your child is making good progress within any individual work and in any group that they take part in.
- A range of ways will be used to keep you informed, which may include:
  - Home/school book
  - Letters/certificates sent home
  - Additional meetings as required
  - Reports

<p><b>What support do we have for you as a parent of child with an SEN/and or disabilities?</b></p>	<ul style="list-style-type: none"><li>• We would like you to talk to your child's class teacher regularly so we know what they are doing at home and we can tell you about what we are doing in school. This is to ensure that we are doing similar things to support them both at home and school and can share what is working in both places.</li><li>• The SENCO is available to meet with you to discuss your child's progress or any concerns/worries you may have.</li><li>• All information from outside professionals will be discussed with you with the person involved directly, or where this is not possible, in a report. The SENCO will also arrange to meet with you to discuss any new assessments and ideas suggested by outside agencies for your child.</li><li>• Homework will be adjusted as needed to your child's individual needs.</li><li>• A home/school contact book may be used to support communication with you, when this has been agreed to be useful for you and your child.</li></ul> <p><b>In addition:</b></p> <p>If you child is undergoing statutory assessment you will also be supported by the Children's Services SEN Team. They will ensure that you fully understand the process.</p>
<p><b>How have we made this school physically accessible to children with SEND?</b></p>	<ul style="list-style-type: none"><li>• The school is accessible to children with physical disability via ramps.</li><li>• We ensure that equipment used is accessible to all children regardless of their needs.</li></ul>

**How will we support your child when they are leaving this school? OR moving on to another class?**

We recognise that 'moving on' can be difficult for a child with SEN/and or disabilities and take steps to ensure that any transition is as smooth as possible.

- If your child is moving to another school:
  - We will contact the new school's SENCO and ensure he/she knows about any special arrangements or support that need to be made for your child.
  - We will make sure that all records about your child are passed on as soon as possible.
- When moving classes in school:
  - Information will be passed on to the new class teacher IN ADVANCE and in most cases, a planning meeting will take place with the new teacher.
  - If your child would be helped by a book to support them understand moving on then it will be made for them if suitable.
- In Year 6
  - The SENDCO will attend the termly Primary Transition liaison meetings to discuss the specific needs of your child with the SENCO of their secondary school,
  - Your child will attend a small group in school, to support their understanding of the changes ahead.
  - Where possible your child will visit their new school on several occasions and in some cases staff from the new school will visit your child in this school.
